900.01 GENERAL POLICY STATEMENT.

An ordinance granting to Northern States Power Company, a Minnesota Corporation, dba Xcel Energy, its successors and assigns, permission to construct, operate, repair, and maintain in the City an electric distribution system and transmission lines, including necessary poles, lines, fixtures, and appurtenances, for the furnishing of electric energy to the City, its inhabitants, and others, and to use the public grounds and public ways of the City for such purposes.

900.03 EFFECTIVE DATE.

901.01 GENERAL POLICY STATEMENT.

An ordinance granting Centerpoint Energy Resources Corp., D/B/A Centerpoint Energy Minnesota Gas, its successors and assigns, a nonexclusive franchise to construct, operate, repair and maintain facilities and equipment for the transportation, distribution, manufacture and sale of gas energy for public and private use and to use the public ways and grounds of the City of Belle Plaine, Scott County, Minnesota, for such purpose; and, prescribing certain terms and conditions thereof.

The acceptance of the ordinance is in effect as adopted by the City Council effective May 16, 2016 and shall be included as an Addendum.

901.03 EFFECTIVE DATE.

The ordinance as described in Section 901.02 shall be in effect for a period of twenty years (20) years starting May 16, 2016 and ending May 16, 2036.

902.01 GENERAL POLICY STATEMENT.

An ordinance granting to Mediacom Cable Communications Company, Incorporated, its successors and assigns, permission to operate and maintain a cable communication system in the City; setting forth conditions accompanying the grant of franchise; providing for the regulation, and use of the system; and prescribing penalties for the violation of its provisions.

902.02 ADDENDUM.

The acceptance of the ordinance is in effect as adopted by the City Council effective September 21, 2015 and shall be included as an addendum.

902.03 EFFECTIVE DATE.

The ordinance as described in Section 902.02 shall be in effect for a period of ten (10) years starting September 21, 2015 and ending September 21, 2025.
