IMPORTANT INFORMATION REGARDING RENTAL LICENSING:

- A RENTAL DWELLING LICENSE HAS NOT BEEN ISSUED, CREATED, OR RENEWED UNTIL AN INSPECTION HAS BEEN CONDUCTED AND PASSED BY THE CITY BUILDING INSPECTOR.
- Application and payment must be submitted prior to scheduling rental inspection.
- A rental dwelling license expires two (2) years after the rental license issue date.
- It is the responsibility of the property owner to ensure the rental license is renewed prior to expiration date.
- All water and sewer service accounts shall be the responsibility of the property owner unless the owner informs the City in writing that the account shall be carried in the name of another person. In any case, the owner shall remain liable for water supplied to the owner's property, whether the owner is occupying the property or not, and any charges unpaid shall be assessed to the property tax statement and be a lien on the property. (City Code 700.05 Subd. 2)
- The property owner is responsible to ensure all corrections are completed. If corrections are not completed within the timeframe specified by the City Inspector or efforts to create a timeline for completion of corrections are unsuccessful, the rental property's registration may be revoked.
- Violations of the rental code and/or a rental dwelling license, including operating without a license are a misdemeanor.
